#### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

Ventilate area of release. Stop the leak if it can be done safely. Contain and absorb any spilled liquid concentrate with inert absorbent material, then place material into a container for later disposal (see Section 13). Contaminated absorbent material may pose the same hazards as the spilled product. Notify the appropriate authorities as required.

#### Section 7. Handling and storage

#### Precautions for safe handling

Wear protective gloves/ protective clothing/ eye protection/ face protection. Protect from sunlight. Do not expose to temperatures exceeding  $50 \, ^{\circ}$ C/122  $^{\circ}$ F. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Use only outdoors or in a well-ventilated area.

Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed.
